Abstract

This paper examined the Sustainable Development Goals (SDGs). Challenges and strategies for its attainment in Nigeria by 2030. Sustainable Development is the Development that meets the needs of the present, without compromising the ability of the future generations to meet their own needs. Therefore Sustainable Development Goals, are set of goals that will guide the attainment of sustainable development in the world. SDGs emerged as a continuation of the Millennium Development Goals (MDGs) which started in 2000. Also bearing in mind that the MDGs were not achieved or attained by 2015 deadline. The Sustainable Development Goals were articulated by Inter-agency and Expert Groups organized by the United Nations. It was on September 25th 2015, that the countries of the world adopted it for implementation for the next 15 years (2016-2030) with 17 goals and 169 targets. Some challenges envisage to hinder its attainment in Nigeria include, late release of fund, corrupt government officials, very poor terrain of most communities and bureaucratic bottlenecks among other things. The paper recommended among other things that Government should sensitize both the public and private sector organizations, Non-Governmental organization and Civil society groups by giving them financial support on the activities that promote human development and wellbeing which is the key of SDGs.

Introduction

According to Inter-Agency and Expert Group of SDG Indicators (2016), sustainable development goals, other wise known as the Global Goals (SDGS) are Universal call to action to end poverty, protect the planet and ensure that all people enjoy peace and prosperity. It is hoped to be achieved by 2030. The Sustainable Development Goals (SDGS) is officially known as Transforming our world. The 2030 Agenda for sustainable development, is a set of "17 Global"

goals with 167 targets between them." It was on September 25th 2015, that countries of the world adopted these set of goals with specific targets to be achieved over the next 15 years. It is spear headed by the United Nations through a deliberate process involving its 193 members states; as well as Global civil society (United Nation, 2015) (www.Un org/sustainabledevelopment/). Sustainable development, is a development that meets the needs of the present, without compromising the ability of the future generations to meet their own needs (Www. Sd-commission.org.uk).

Therefore, SDGs are sets of goals that will guide the attainment of sustainable development.

Attainment is the action or facts of achieving a goal towards which one has set or worked. The SDGs and it indicators as listed by United Nation's Statistical Commission (2016) are shown below, with (E/CN.3/2016/2 Rev.1) reference document:-

Challenges that may likely hinder the attainment of these sustainable development goals (SDGS) by 2030 in Nigeria.

It should be understood that SDGS emerged as a result of unfulfilled and unattained Millennium Development Goals which had 8 goals and 18 targets with 48 indicators launched in 2000, which ended in 2015. While sustainable development goals was adopted by the world leaders for implementation in September 2015 at a historic United Nations Summit.

The MDGS in Nigeria suffered lots of setbacks and obstacles during its implementation; and if care is not taken the same thing may likely affect the implementation of the on-going Sustainable Development Goal Programmes in Nigeria. Such Challenges according to, Nwobodo, Ugwu, Onyia and Amakom (2015:14-44) include, late release of funds, bureaucratic bottlenecks in programme implementation, wrong project location, very poor terrain of most communities, as the projects are sited in remote areas.

Also most Communities do not have communal land where these projects could be sited and this resulted in projects being relocated at times, youth restiveness in some parts of Nigeria and the increased number of Internally Displaced Persons (IDPS) as a result of Boko Haram Suicide attacks; Fulani herd men and farmers conflicts, intertribal wars. In view of all these challenges that befell the attainment of millennium Development Goals (SDGS) it is imperative to forestall its occurrence in the attainment of sustainable Development Goals (SDGS).

Some strategies are required to ensure the attainment of Sustainable Development Goals: Strategy could be define as, a plan that is intended to achieve a particular purpose. It can also mean the art of putting a plan into operation in a skillful manner with the aim of achieving set objectives. In the context of this paper therefore, strategy refers to the necessary plan that need to be put in place so that the Sustainable Development Goals can be achieved in

Nigeria by 2030.

- There should be a meeting of relevant Government agencies/ Stakeholders and donor agencies on SDGs implementation in Nigeria based on the indicators highlighted above.
 - All money meant for the implementation of SDGs should be released on time and monitored for proper expenditure.
 - The Government in power should demonstrate a strong political will in providing the necessary human and material resources for its attainment.
 - Private sectors should be involved to participate in project implementation of SDGs, because of the corporate social responsibilities they carry out to humanities.
 - Setting up of SDGs Committees and Desk Officers at the Federal, State and Local Government levels, as well as in Agencies, Ministries, Boards,
 - Primary, Secondary and tertiary institutions are important committees should equally be constituted at the Senate, Federal House of Representative and the State Houses of Assembly.
 - The Sustainable Development Goals, targets and indicators should be included in the school curriculum (Primary, Secondary and tertiary), and be properly taught to students with corresponding implementation
 - -There should be a transparent monitoring team to check corruption,
 - because the inordinate corrupt tendencies of government officials and
 - their conspirators will undermine the efforts of Government towards the achievement of SDGs.
 - There should be political stability and the continuation of the programme/ project by the new government.
 - The projects/ facilities should be evenly and equitably located -especially in the rural Areas.
 - Many people are ignorant of what Sustainable Development is all about, therefore there should be massive orientation and involvement of all the strata of the society in the implementation of SDGs. Government should evolve a policy for the implementation.

Conclusion

This paper defined what Sustainable Development is all about, and its goals. 17 of the Goals were listed out and their indicators explained. Likely hindrances to its attainment were highlighted and strategies for its achievement stated.

Recommendations

In addition to about 10point strategies suggested, which will enhance the attainment of Sustainable Development Goals in Nigeria. (1) Government at all

levels should ensure a stable and peaceful political environment, and sensitize public and private sector organizations, Non-Government organizations (NGOs), the Civil society groups etc, and financially support their activities that promote the achievement of SDGs, among other things.
